
2. Registration Flow of Japanese Language and Culture Courses

You are required to take Japanese Language Placement Test Every Spring Semester if you wish to take Japanese Language and Culture Subjects for international students. You will not be allowed to take the courses if you have not taken the Placement Test. X You cannot carry over the Japanese Level of the previous years.



"Japanese Language Introductory Course" cannot be registered on DUET since it is extracurricular. For registration, please ask the office of your faculty/graduate school.

(1) Japanese Language Placement Test

- It is an online test to determine student's Japanese learning level.
- The placement test consists only of an online test. There will be no oral exam. However, there may be cases where consultation at counseling for course registration is required to finalize the Japanese learning level.
- \cdot Please see p13 of this book for details about the test schedule.
- \cdot We will not accept any inquiry regarding the test format, examination questions and past examination questions.
- New students entering in fall semester can take the placement test in fall semester only in their enrollment year and must take it in spring semester after the second year.


(2) Students required to take the Japanese Language Placement Test

Those who meet the following conditions 1 and 2 are required to take Japanese Language Placement Test.

* ② does not apply to ILA students.

①International Students (regular students or special students) enrolled in Doshisha University and who wish to learn Japanese Language and Culture.

②International Students (regular students or special students) who are determined as "Required to Take Japanese Language Placement Test" by the Japanese level determination chart shown below.



Q: Do I have to take Japanese Language Placement Test each year?

A: Yes. Students are required to take the test every year if they wish to take the Japanese Language and Culture Subjects. Japanese learning level is designated for each academic year.



Q:I was determined as "Required to take Classification Test for introductory course" on the "Japanese level determination chart". Does this mean I can't study Japanese?

A: "No need to take Japanese Language Placement Test Required to take Classification Test for Introductory course" means your Japanese Language level will not reach Level 1 even if you take the Placement Test. This means that you cannot register for the Japanese Language and Culture Subjects. For these students, however, we offer Japanese Language Introductory Course (Note: This is a non-credit extracurricular course). For details, please contact your faculty/graduate school's office.

Every year, we see some students taking the Classification Test (for Introductory Course) without checking the Japanese level determination chart. Because of this failure to check, we have encountered instances in the past where the students' Japanese level turned out to be much better, meaning that these students should have taken the Japanese Language Placement Test, not the Classification Test (for Introductory Course). Because <u>these students have not taken the Japanese</u> <u>Language Placement Test and therefore not assigned to any</u> <u>Japanese language level (even at Level I), they will not be</u> <u>able to register or take any Japanese Language and Culture</u> <u>Subjects and Japanese Language Introductory Course during</u> <u>the semester.</u>

If you wish to register for the Japanese Language and Culture Subjects or the Japanese Language Introductory Course, it is important that you <u>do not judge your Japanese proficiency on</u> <u>your own. Please make sure to check the Japanese level</u> <u>determination chart and take the test which suits your</u> <u>current Japanese language skills.</u>

Fall Semester

- For new students entering in the fall semester, details of the Japanese language Placement Test will be provided in the orientation materials.
- As a general rule, current students are not allowed to take the placement test in the fall semester. If you were unable to take the placement test in the spring semester and wish to take Japanese language and culture subjects in the fall semester, you should apply for fall semester placement test as follows.

The detailed information of the fall semester placement test will be sent on September 9th to Doshisha account email of those who have applied.

※ You cannot register Japanese language courses at a Japanese level different from those designated by the test. However, you may have to take Japanese subjects at a different level due to the overlap in the timetable with your faculty /graduate school's compulsory subject. In such cases, or for any concerns you might have with registration, please consult at the "Counseling for course registration." If you register for a subject at a different level and fail to attend the counseling session, your registration will be treated as a registration error. You will be required to correct this error during the registration error correction period, but if you fail to do so during this period, the subject flagged with registration error will be deleted.

(4) Course Registration and Registration Error Correction

• You can register Japanese Language and Culture Subjects on your own using the DUET system.

• All courses other than the Advanced registration courses listed in this guide are General registration courses.

• Please check the university website or contact your faculty/graduate school office for information about the advanced registration period and general registration period.

• You must register courses based on the designated Japanese level/class (class is designated only in levels I-III at Imadegawa campus.) determined by the result of the test.

In case you register the subject with different level/class and fail to attend the counseling, your registration will be treated as registration error.

• For courses with registration error, you should either correct the registration to the designated level or delete the course from your registration during the error correction period through your faculty/graduate school's office. If you do not do either one, all courses with registration error will be deleted.

 \cdot You cannot register courses at different Japanese levels / classes within the same semester without permission.

Q: I have been notified that my Japanese Level was "VIII" as the result of the test. I would like to register for "Grammar" and "Vocabulary" this semester, but I am not good at "Grammar", so I would like to lower the level for grammar and register for Level VI at my own discretion. Would it be all right??



A:Be sure to register courses with the designated Japanese level. In addition, students are not allowed to register Japanese language courses at different levels in the same semester without permission. If you wish to register for more than one Japanese language course at different levels in the same semester, please be sure to attend counseling for course registration and consult the instructor. In case you register the subject with a different level / class and fail to attend the counseling, your registration will be treated as registration error, which needs to be corrected during the designated period. If you fail to correct this error, the subject with registration error will be deleted.

- Please register Japanese language and culture subjects at the designated Japanese level determined by the result of the test for the academic year. You are not allowed to register for Japanese language courses at different levels in the same academic year without permission. However, the level of the Japanese language subjects offered at the Imadegawa Campus (Levels I-III 101 class) will change within the same academic year.
 - Q:I have been notified that my Japanese Level was "VI" as the result of the test. So, I registered Japanese Language subjects at the designated level, VI, in the spring semester. However, I feel level VI is too easy, so I decided to register for the higher VII level courses in the fall semester. Would this be all right?

A:Be sure to register only for the VI level courses within the academic year. Students cannot register for different levels of Japanese language courses in the same academic year without permission. Students must register for courses at the designated level. If there is a specific reason to register for a Japanese course in the fall semester that is at a different level from the spring semester, please be sure to consult at "Counseling for course registration" for the fall semester. If you register a subject(s) with a different level / class and fail to attend counseling, your registration will be treated as registration error and will require correction during the designated period. If you fail to correct the error, the subject with registration error will be deleted.



Q:I have been notified that my Japanese Level was "VI", but on the DUET registration screen, I see a lot of courses for other levels. Does this mean that I can register for courses at other levels?

A:NO. You must register for courses at the designated level determined by the result of the test. If the timetable of the designated Japanese subject overlaps with your faculty /graduate school's compulsory subject, or if you have any concerns regarding the course registration, please be sure to consult at the "Counseling for course registration." If you register a subject at a different level and fail to attend counseling, your registration will be treated as registration error; this will require correction during the designated period. Failure to correct the error will result in deletion of the subject registration.
